Note: Count 10 was changed to PC288(a) (see body of the Information and page 2 of the April 21, 1995 minute order). Counts 1-3, 6, 10, 13, and 14 were declared a mistrial. According to Deputy District Attorney Kay Neshat-Hersh, there is a possibility that these counts will be dismissed or retried at the Pronouncement of Judgment/Pre-Trial hearing now set for June 30, 1995. This transmittal is being sent at this time because of the felony/moral turpitude requiring interim suspension classification as to the conviction on the other counts.


