If Contreras cannot be found, after diligent attempts which satisfy the Office of Probation, then monthly payments must be made to Gonzales until paid, and then to the Client Security Fund on behalf of Contreras, until the amount owed is paid. If Contreras is not initially found, but later is located, then the monthly payments to Gonzales will


