The court has considered the papers filed in this matter. **GOOD CAUSE APPEARING THEREFOR**, the motion is **GRANTED**. The court makes the following orders:

1. Respondent must pay the entire amount of restitution owed by **July 31, 2014**, at the increased rate of a total monthly payment of at least **\$150.00**; and
2. Respondent must provide satisfactory proof of payment to the Office of Probation with each quarterly probation report.


