The request of Margolis & Margolis for amicus curiae status is granted. The motions of the State Bar and of Respondent Davis to augment the record are denied. The Review Department modifies the slip opinion filed in the above-entitled matter on August 2, 2003, as follows:

1. Page 2: Inserts a period after the word "dispute" on line 7 and deletes the remaining portion of the sentence which states, "and an additional \$2,500.00, plus interest, which equals the amount of the sanctions imposed on him by the United States Bankruptcy Court."
2. Page 9: Deletes the word "no" at the end of line 21".
3. Page 13: Deletes the sentence at lines 2-5 which begins with the word "concomitantly" and ends with the citation to *In the Matter of Fonte*.
4. Page 32. Deletes the following clause at the bottom line of the page which reads "or court ordered sanctions (see, e.g., *Hunnicutt v. State Bar* (1988) 44 Cal.3d 362, 367, 374)".
5. Page 33: Revises the citation that appears at line 14 to read, "(See *In the Matter of Fonte* (Review Dept. 1994) 2 Cal. State Bar Ct. Rptr. 752, 765.)".
6. Page 34: Deletes the paragraph at lines 7-18 which begins with the word "Furthermore" and concludes with the word "binding".



7. Page 35: Deletes the portion of the sentence appearing in line 6 of paragraph number 1 which reads, "plus restitution to CERT Environmental Corporation, or its successor in interest, in the amount of \$2,500, plus interest thereon at the rate of 10 percent simple interest per annum from September 30, 1996, until paid".

In all other regards, the motion for reconsideration is denied.
