
On August 4, 2006, this court ordered respondent involuntarily inactive pursuant to Business and Professions Code section 6233, effective as of July 10, 2006. On October 2, 2009, respondent, by his counsel, Michael G. Gerner, filed a request that the court terminate the inactive enrollment, on the grounds, *inter alia*, that respondent had substantially complied with his obligations in the Alternative Discipline Program (ADP), and that respondent had been inactive for over three years, when his low level of discipline in the ADP was only one year. The Office of the Chief Trial Counsel, by Charles A. Murray, opposed the request.

The court has carefully monitored respondent during this period of participation in the ADP. While he has had some difficulties timely paying all the restitution he was obligated to pay, he has repaid a substantial portion of the amount owed, including almost all the principal owed to the complaining witnesses. He has consistently remained in compliance with the requirements of the Lawyers Assistance Program, receiving positive reports in 26 of the 27 reports since July 2004.

Based on the above, and on all the papers on file in this action, and **GOOD CAUSE APPEARING THEREFOR**, the involuntary inactive enrollment of respondent Mervyn H. Wolf, imposed effective July 10, 2006, pursuant to Business and Professions Code section 6233, is terminated, *nunc pro tunc*, on October 14, 2009, upon his payment of any applicable fees and costs.

IT IS SO ORDERED.


