**FURTHER MODIFICATION ORDER**

On February 10, 2004, at the request of the parties, a status conference was held to clarify the Court's concern as to the inconsistencies in the stipulation filed on December 15, 2003, as described in the Court's Modification Order filed February 4, 2004. Geri von Freymann, Esq. appeared for the Office of the Chief Trial Counsel and Michael E. Wine appeared for Respondent.

In order to correct these inconsistencies, the parties agree to the following further modifications:

1. The Modification Order dated February 4, 2004 is vacated.

2. Paragraph 1(A)(iii) on page four of the stipulation is removed in its entirety.

3. Paragraph (a) on page six of the stipulation is removed in its entirety, and the following language is substituted in its place:

"Respondent shall file an accounting as previously ordered in San Diego Superior Court case no. P171050 within one (1) year of the effective date of the discipline herein. Respondent shall further pay any restitution ordered by the San Diego Superior Court in that case within either one year after the effective date of the




