Pursuant to Business and Professions Code section 6233, respondent **BEHROUZ SHAFIE** (“respondent”) is enrolled as an inactive member of the State Bar of California effective ~~April~~ ^{July} 1, 2008, and until further order of this court. Respondent will remain on inactive enrollment under section 6233 for at least one year.

Within 30 days after the effective date of his inactive enrollment, respondent must comply with the following requirements set forth in rule 9.20 of the California Rules of Court as hereby modified in this order.

1. Notify all clients being represented in pending matters and any co-counsel of his inactive enrollment pursuant to Business and Professions Code section 6233 and his consequent disqualification to act as an attorney effective ~~April~~ ^{July} 1, 2008.¹ In the absence of co-counsel, respondent must also notify his clients to seek legal advice elsewhere, calling attention to any urgency in seeking the substitution of another attorney or attorneys;

¹ The operative date for identify the “clients being represented in pending matters” and all others to be notified of respondent’s disqualification to act as an attorney under this order is the filing date this order and not the effective date of respondent’s inactive enrollment. (Cf. *Athearn v. State Bar* (1982) 32 Cal.3d 38, 45 [applying former rule 955; which was renumbered rule 9.20 eff. Jan. 1, 2007].)

2. Deliver to all clients being represented in pending matters any papers or other property to which the clients are entitled or notify the clients and any co-counsel of a suitable place and time where the papers and other property may be obtained, calling attention to any urgency for obtaining the papers or other property;

3. Refund any part of fees paid that are unearned; and

4. Notify opposing counsel in pending litigation or, in the absence of counsel, the adverse parties, of respondent's inactive enrollment and consequent disqualification to act as an attorney effective ^{July} April 1, 2008, and file a copy of the notice with the agency, court, or tribunal before which the litigation is pending for inclusion in the respective file or files.

All notices required by this order must be given by registered or certified mail, return receipt requested, and must contain an address where communications may be directed to respondent.

5. Furthermore, within 40 days after the effective date of his inactive enrollment, respondent must file with the Clerk of the State Bar Court an affidavit showing that he has fully complied with the requirements set forth above. The affidavit must also set forth an address where communications may be directed to respondent.

IT IS SO ORDERED.


