On December 15, 2017, respondent Joseph Henry Marman filed a motion requesting the court waive the disciplinary costs he was ordered to pay in this matter. (Rules Proc. of State Bar, rule 5.130.) On December 27, 2017, the Office of Chief Trial Counsel of the State Bar of California filed its opposition. Respondent filed a reply on January 12, 2018.

The court **DENIES** respondent's request for full relief from payment of the costs. However, good cause having been shown, the court **ORDERS** that the time in which respondent must pay the assessed disciplinary costs is extended and respondent may pay in installments. (Bus. & Prof. Code, § 6086.10, subd. (c).) Respondent has been assessed \$7,609.00 in costs. Respondent must pay the costs in two equal installments: the first installment, in the amount of \$3,804.50, will be due on February 1, 2019; and the second installment, in the amount of \$3,804.50, will be due on February 1, 2020. The court further **ORDERS** that if respondent fails to pay any installment of disciplinary costs within the time provided herein or as may be modified by the State Bar Court pursuant to Business and Professions Code section 6086.10, subdivision (c), the remaining balance of the costs is due and payable immediately unless relief has been granted under the Rules of Procedure of the State Bar of California (Rules Proc. of

State Bar, rule 5.134). The payment of costs remains enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

IT IS SO ORDERED.
