On November 8, 2012, Respondent filed a motion seeking a stay of the effective date of his inactive enrollment. The motion sets forth ample evidence that Respondent's clients will be prejudiced if a delay in the effective date is not granted. The motion also states that Respondent has concurrently filed a request for review with the Review Department.

GOOD CAUSE APPEARING, the court grants a temporary stay of the effective date of Respondent's inactive enrollment under Business and Professions Code section 6007, subdivision (d) until midnight, November 27, 2012. That stay will provide Respondent the opportunity to seek a further stay from the Review Department and also afford the State Bar an opportunity to file an opposition to the request, while simultaneously protecting the interests of Respondent's clients during this briefing process. Respondent will be enrolled inactive on November 28, 2012, absent a further order to the contrary from the Review Department.


