19 Respondent SEAN SURESH CHANDRA, a member of the State Bar of California,  
20 responds as follows to the notice of disciplinary charges (the "Notice") filed by the Office of  
21 the Chief Trial Counsel, as follows:

- 22 1. Respondent ADMITS the allegations made in paragraph 1 of the Notice related to  
23 jurisdiction.
- 24 2. Respondent ADMITS that Waverlyn White ("Claimant") employed Respondent to  
25 perform legal services, to wit: Claimant employed Respondent to defend her in an  
26 unlawful detainer proceeding brought against her for failure to pay rent. Claimant also  
27 employed Respondent to file a civil habitability lawsuit against her former landlord.

- 1 3. Respondent DENIES the allegations made in paragraph 2 of the Notice that allege that  
2 “Respondent intentionally, recklessly, or repeatedly failed to perform with competence,  
3 in willful violation of Rules of Professional Conduct, rule 3-110(A), by failing to  
4 provide any service of value to his client.”
- 5 4. Respondent DENIES the allegations made in paragraph 3 of the Notice that allege that  
6 “Respondent failed, between June 16, 2012 and December 12, 2012, to respond  
7 promptly to multiple telephone messages, emails and a letter from Respondent’s client,  
8 Waverlyn White, that Respondent received in a matter in which Respondent had agreed  
9 to provide legal services, in willful violation of Business and Professions Code, section  
10 6068(m).”
