- 17 1. I have been a member of the State Bar since 1955.
- 18 2. As a condition to my probation, I was to pass the Multistate Professional Responsibility
19 Examination. ("MPRE"). I took the MPRE two times in March 2014 and in November 2014. In
20 each examination I did not pass.
- 21 3. In the March 2014 MPRE, I did not receive a result until it was too late to request a
22 verification.
- 23 4. In the November 2014 MPRE, I made a timely request for a verification, but it has not been
24 received.
- 25 5. I have been, and remain, willing to the performance of said condition.
- 26 6. On October 29, 2014 I received from the State Bar of California congratulations on completion
27 of Ethics School (Exhibit A).

7. Since I received the test score on the November 2014, I have acted as follows:

- a. On April 7, 2015 I sent a letter to Nina Yazdani, stating factors in my favor (Exhibit B).
- b. On April 21, 2015 I sent a letter to the National Conference of Bar Examiners regarding the possibility of my scores being falsified. (Exhibit C). No response has been received.
- c. On April 21, 2015 I applied for a private tutor. (Exhibit D). No response has been received.
- d. On April 21, 2015 I applied for a State Bar Court Hearing (Exhibit E). No response has been received.

8. I will seek another MPRE test, but I would like to receive verification of the November 2014 test score.

9. In view of the foregoing, I propose a waiver of the BPRE requirement of a passing score on the BPRE test. Since I was admitted as an attorney in 1955, there has been an absence of any complaint against me regarding ethics. Surely, 60 years of an unblemished record outweighs any BPRE score.
